 - a. Motion made by Commissioners Patterson / Riesinger to nominate and re-elect Susan Loppnow to the position of Commission President,
 - b. Motion made by Commissioners Riesinger / Patterson to nominate and re-elect Chris Rebholz to the position of Commission Vice President,
 - c. Motion made by Commission President Loppnow and seconded by Commissioner Rebholz to nominate and elect Commissioner Riesinger to the position of Commission Secretary,

The motions to elect each candidate, as nominated, carried.

All Commissioners officially welcomed Trevor Deboer the newest Commissioner to the Board of Police and Fire Commission.


3. Fire Department 2020 Annual Report: Fire Chief Jambretz.
 - a. Chief provided a high-level report on the significant accomplishments of 2020,
 - i. Acting as Interim Chief then transitioned to position as Chief,
 - ii. Major shift in the Departments organizational and support positions.
4. Fire Department Update and Monthly Report: Fire Chief Jambretz.
 - a. HFD received National attention on their “blitz” attack strategy in fighting the Summit Lakes fire,
 - b. Total calls so far this year is 21 less than the 2020 year.
5. Police Department 2020 Annual Report: Police Chief Misko.
 - a. Chief provided a high-level report on the significant accomplishments of 2020,
 - i. Mutual aid agreements with the surrounding agencies for additional assistance when necessary,
 - ii. The continued campaign to strengthen advocacy between the community and the department.

6. Police Department update and Monthly Report: Chief Misko
 - a. Officer Matt Shea officially started 10 May 2021,
 - b. Matt and his father presented to the Chief a thank you letter designated to the Board of Police and Fire Commission,
 - c. Officer Mark Jorgenson's official last day as a Hartland Police Officer is 17 May, 2021,
 - i. A celebration will be held at the Village to thank Officer Jorgensen for his dedication and service to the Hartland police Department,
 - d. The previous police department candidate interview list is insufficient to render a hiring decision and the chief is proposing to conduct a short-term advertisement for certified law enforcement candidates to establish a new candidate list,
 - e. A legislative roundtable was conducted with state representatives to discuss the topic of police reform. The discussion included a discussion on the public's perception of law enforcement officer behavior and training,
 - f. Waukesha County Health and Human Resources is looking into closing the Juvenile Center in Waukesha County,
 - g. A major bike race to be held in Hartland on 23 June, 2021, will close major roadways in the Village between the hours of 1000 and 2200 hours,
 - h. Chief Torin will be a speaker at the Waukesha County Law Enforcement Memorial Ceremony.

7. Consideration of a Motion to Adjourn
 - a. There being no further business to come before the Village Board of Police and Fire Commission, and on motion to adjourn by Commissioners Patterson / Rebholz, the motion carried.
 - b. Meeting adjourned at 2034 hours.
