1. 1900 hours meeting called to order by Commission President Loppnow.
2. Commission Secretary Riesinger read the roll for attendance,
 - 2.1 Present: Commissioners Loppnow, Rebholz, Riesinger, Deboer,
 - 2.2 Commissioner: Patterson, excused,
 - 2.3 In attendance: Police Chief Misko, Fire Chief David Jambretz, Police Deputy Chief Collura, Police Captain Kelsey.
3. Pledge of Allegiance led by Commission President Loppnow.
4. Consideration of a motion to approve the Board of Police and Fire Commission minutes for the meeting of 8 March 2022,
 - 4.1 Motion by Commissioners Rebholz | Deboer to approve the Board of Police and Fire Commission minutes for the meetings of 8 March 2022, carried.
5. Fire Department Report: Fire Chief Jambretz,
 - 5.1 SCBA goes into service after the fit testing and training is complete,
 - 5.2 Turnout gear received and is in the process of being uploaded in the PSTrax system,
 - 5.3 Fire burn training at house located at Hwy K.
6. Police Department Report: Police Chief Misko,
 - 6.1 On 04/10/22 car chase and arrest occurred in Hartland. Subject was pursued on East Capitol Dr. to subjects residence on Lisbon Av., where subject was arrested after a brief foot pursuit. Currently under further investigation,
 - 6.2 Village of Chenequa Police Chief, recognized Hartland Officer Zach Bell for assisting Chenequa Officer Ryan Brehmer with a water rescue on Beaver Lake, Sunday 4/10/22. The officers quick action to rescue the victim occurred in 13 minutes after being dispatched to the scene. The victim suffered from hypothermia. Noted: water temperature was approximately 45 degrees with sustained winds of 20 mph. This incident could have easily been a recovery, rather than a rescue.

Presiding Commission President Loppnow requested a motion to recess to closed session pursuant to State Statutes §19.85 (1)(c), considering employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility related to interviewing candidates for Firefighter/EMT and Police Officer.
